## **OBJECTIVE**

The purpose of the Conference is to reflect about the European Public Prosecutor's Office (EPPO), which marks one further step in the development of the Area of Freedom, Security and Justice and in European integration in criminal matters more broadly. The Conference will address both EPPO's institutional setting (within the context of its relations with other EU agencies and with the Member States) and EPPO's organic framework (its internal organisation). It will also address its substantive and investigative competences, as well as the guarantees provided to targeted individuals.

This call is open to contributions drawing on any of the mentioned topics, but also from other perspectives that, while not mentioned, can concur to the envisaged critical reflection about the EPPO.

# SUBMISSION, SELECTION AND PRESENTATION OF COMMUNICATIONS

Those interested in presenting a paper at the Conference should submit an application by the 30<sup>th</sup> of April 2022, with a maximum of 750 words (approximately 2 pages), in Word format, together with a *curriculum vitae* of approximately the same size, to <a href="mailto:aidp.portugal@gmail.com">aidp.portugal@gmail.com</a>. By the 1<sup>st</sup> of June 2022, the Selection Committee shall made public its decision on the selected applications.

Candidates may be any young penalists (up to 35 years old, *inclusive*). In order to present their papers at the Conference, successful candidates who are not members of the AIDP will be required to enrol in the Association (in <a href="www.penal.org">www.penal.org</a>) or, alternatively, pay a registration fee to the Conference of € 45 (equivalent to the annual fee of the AIDP).

Selected papers shall be presented in person in a panel of the Conference specifically dedicated to Young Penalists, with each communication having a duration of approximately 15 minutes. Communications may draw on unpublished work developed by the candidate, including doctoral theses, and they may be delivered in Portuguese, Spanish or English.
